

# Join the Dots Programme Free Prize Draw

#### **Terms and Conditions**

### 1 How to participate

- 1.3 By entering this prize draw you agree to be bound by these Terms and Conditions.
- 1.4 No payment is necessary to enter this promotion.
- 1.5 All participants must be aged 18 or over by 1 September 2024. Any participants under 18 at the time of entry must get consent from their parent(s) or legal guardian(s) before entering. The parent(s) or legal guardian(s) of entrants under 18 agree to these Terms and Conditions on behalf of the participant.

- 1.7 Each participant will be entered once into the draw. Multiple entries per person are not permitted.

#### 2 Start date

2.1 This promotion will start on 1st September 2023.

## 3 Closing date

3.1 The closing date for this promotion will be 29<sup>th</sup> September 2024 at midnight. Entries received by the promoter after this time will be void and will not be entered into this promotion.

#### 4 Selection of the winner

- 4.1 Only one winner will be selected.
- 4.2 The winner of the prize draw will be the first participant randomly selected from all entries correctly submitted in accordance with these terms and conditions.
