

The Scholars Programme Free Prize Draw Terms and Conditions

1 How to participate

- 1.6 All participants must be professionally affiliated with a state school or college, delivering Key Stages 2-5, in the United Kingdom.
- 1.7 Entries that do not comply with these terms and conditions will be void and will not be entered into this promotion.
- 1.8 Each participant will be entered once into the draw. Multiple entries per person are not permitted.

2 Start date

2.1 This promotion will start on 1st June 2024.

3 Closing date

3.1 The closing date for this promotion will be 30th June 2024 at midnight. Entries received by the promoter after this time will be void and will not be entered into this promotion.
